Held June 20, 2022

Cardington Township held a special meeting on June 20, 2022 at 7:00 PM in the township garage. The meeting was opened with pledge to flag and prayer by Heacock.

Trustees: Heacock, Patterson, Green.

Fiscal Officer: Hardwick.

Zoning Inspector: Robinson.

Employees: Bouillon, Moss, Wilhelm.

Others: Kelly Beveridge, Scott Beveridge, Steven Hummell Jr., Cinnamon Potter, and David Smith.

MINUTES:

* Hardwick read the minutes of the May 9th meeting. Patterson moved, Heacock seconded, to approve the minutes as read. Roll Call: Heacock yes, Patterson yes, Green yes.

FINANCIAL:

* The following bills were presented to the board for examination (listed at end of minutes): 16529-16553. Patterson moved, Heacock seconded, to approve said bills. Roll Call: Heacock yes, Patterson yes, Green yes.

* Hardwick presented the Township's Cash Summary by Fund report and Fund Status report. The May bank reconciliation was distributed for signing by the board. Heacock moved, Patterson seconded, to accept them as submitted. Roll Call: Heacock yes, Patterson yes, Green yes.

ZONING:

* #477 Cynthia Thompson, 2129 CR 11 room addition - cost of construction is less than \$10,000 - fee \$10.00.

* Robinson reported that he received a complaint that the Beveridge property on CR 137 has not been mowed. Robinson mailed a letter to the 1776 CR 137 address (that does not have a mailbox) and the address on the property tax duplicate (LaRue, Ohio). Trustees will discuss mowing this property at the July meeting if the property owner has not taken care of it.

* Robinson shared that he inspected the Maniaci property on Sunday. It had been mowed. There was a truck and trailer with some of the junk loaded on the trailer. He deemed it to be progress. He will continue to check on the property; Heacock said he would also.

* Robinson also received a complaint about the brick house at 4551 TR 66. He will send a letter to the owner, MK Capital LLC, as stated on the tax duplicate.

ROADS:

* Heacock thanked the road workers for all their hard work to clean up after the storms the previous week. He said that Wilhelm provided his own chainsaw and equipment during the storm. Heacock moved, Patterson seconded to pay Wilhelm \$200 for the rental of Wilhelm's equipment during the storm. Wilhelm needs to provide an invoice. Roll Call: Heacock yes, Patterson yes, Green yes.

* Wilhelm reported they have cleared the downed trees off the roads, mowed ditches twice, and started patching roads with hot mix. Crawford Construction Co. has completed the culvert projects on TR152 and TR144. Wilhelm has not received a start date from Iberia Earthworm for summer paving and chip and seal. Gordon Excavating has not jetted out the culvert on TR138 yet. Wilhelm discussed a drainage issue near Ben Clinger's on TR132; he proposes putting in a second culvert.

* Crawford Construction Co. inspected the culvert at TR144 and CR125. They proposed a temporary fix at an approximate cost of \$3,000 - \$4,000 so that it does not wash out farther. The County offered to provide pipe if the Township provides the labor.

EQUIPMENT:

* Heacock moved, Green seconded, to purchase a chainsaw from Miller Equipment with a cost up to \$500. Roll Call: Heacock yes, Patterson yes, Green yes.

* Heacock discussed the purchase of a generator for the Township garage – possibly use ARPA funds. He will get some price quotes.

* The dump truck is at the shop. The high water and orange/black barber signs are installed. Wilhelm has ordered a few replacement road number signs.

MISC:

* Hardwick reported that the Township had a BWC audit on June 7 at her house; there were no findings. The Township paid Gompf Funeral Service for an indigent burial; Hardwick will apply to the State of Ohio for reimbursement.


* Heacock moved, Green seconded, to pay Bart Wilhelm to mow the yard at the Township building at \$50/mow. Wilhelm will provide the equipment and do it on his own time. The Township does not own a mower and deem it more cost effective to hire this service out. Roll Call: Heacock yes, Patterson yes, Green yes.


* Potter shared her displeasure of the status of the Maniaci property. Beveridge reported that he installed a culvert on his property; Wilhelm told him he would deliver a load of gravel when the dump truck is repaired.

* Heacock discussed the propane pre-pay offer from Central Ohio Farmers Co-Op. Hardwick will prepare a check for the July meeting to pre-pay for 700 gallons of propane.


* Wilhelm stated he plans to resign in August. Trustees asked him to put it in writing.

Patterson moved, Heacock seconded, to adjourn. Time 7:45 PM.
