Cardington Township held their regular meeting on April 11, 2022 at 7:00 PM in the township garage. The meeting was opened with pledge to flag and prayer by Heacock.

Trustees: Heacock, Patterson, Green.

Fiscal Officer: Hardwick.

Zoning Inspector: Robinson.

Employees: Bouillon and Wilhelm.

Others: Louis Cortez-Iberia Earthworm Construction, Keegan Moss, Cinnamon Potter and Mr. Hummel, James Everman, Joe Sherman, and David Smith.

ROAD BID:

* The Township received and opened one bid for summer road work. It was from Iberia Earthworm Construction as follows:

• Repave TR 136 – from TR130 to Gilead Twp (1.3 miles x 19' wide)	\$92,896.40
• Chip & Seal TR 28 – from StRt 529 to CR11 (1 mile x 18' wide)	16,120.80
• Chip & Seal TR 134 – from TR136 to CR27 (1 mile x 18' wide)	16,120.80
TOTAL	\$125,138.00

* Trustees discussed the County's bid for road repaving is \$63/ton and that the County has not yet bid chip and seal at this time. Patterson moved, Heacock seconded to award the bid to Iberia Earthworm in the total amount of \$125,138.00 as the lowest and best bid. Roll Call: Heacock yes, Patterson yes, Green yes.

* Iberia Earthworm Construction also submitted a sealed proposal for repaving both lanes of TR 124 - half of 455' farthest east. (Refer to minutes from February 14, 2022 meeting.) Cortez confirmed that his proposal is for 270' x 20'. The total proposal is \$14,390.00. Trustees discussed that this proposal is approximately \$5,000 less than the Village Engineer's estimate. Green moved, Heacock seconded, to either pay the Village up to \$14,390.00 toward their cost to repave East Main Street/TR 124 or to accept the proposal from Iberia Earthworm Construction in the amount of \$14,390.00. This will be at the discretion of the Village. Roll Call: Heacock yes, Patterson yes, Green yes.

MINUTES:

* Hardwick read the minutes of the March 14th meeting. Patterson moved, Green seconded, to approve the minutes as read and amended. Roll Call: Heacock yes, Patterson yes, Green yes.

FINANCIAL:

* The following bills were presented to the board for examination (listed at end of minutes): 16488-16514 and electronic payments 4 & 5. Heacock moved, Patterson seconded, to approve said bills. Roll Call: Heacock yes, Patterson yes, Green yes.

* Hardwick presented the Township's Cash Summary by Fund report and Fund Status report. The March bank reconciliation was distributed for signing by the board. Heacock moved, Patterson seconded, to accept them as submitted. Roll Call: Heacock yes, Patterson yes, Green yes.

* Hardwick shared that the first report to the US Department of Treasury for American Rescue Plan federal funds is due April 30. Trustees briefly discussed ideas for use of funds. They will bring ideas for spending to the next meeting.

ZONING:

* #475 Kelly Beveridge, 1756 CR 137 pole barn extension – cost of construction \$40,000 - fee \$40.

* Robinson has received complaints about 1415 CR 149. There are many junk mowers at the rear of the property and much junk everywhere on the property. Robinson stated he sent a letter to the property owner March 8, 2020 that went with no response. The property owner passed away December 2020 and relatives are now living in the house. The property taxes are not being paid. The neighbors of the property were in attendance at the township meeting and shared photos. Green will contact the Health Department and Heacock will contact the County Prosecutor.

ROADS:

* Wilhelm reported the roads are wet. They will start using cold patch to repair holes when weather dries. Hot patch may start being sold around May 1.

* Heacock spoke to County Engineer and Green inspected County maps. The culvert at TR 144 and CR 125 appears to be the Township's responsibility.

EQUIPMENT:

* The equipment is in good shape. The Dexter Company sent the wrong size plate for the mower – correct one is on the way. Heacock priced a portable torch for about \$100; he discussed that it might be worth the money to purchase a bigger one.

MISC:

* Hardwick reported that the Township received the special assessment of property taxes assessed to the Beveridge property that the Township cleaned up. She had to order checks and envelopes. The Township will need to increase appropriations for road paving on East Main Street/TR 124 – she will put that on next month's agenda.

* Township will meet with Village on May 2 at 6:30 PM for cemetery business.

* Heacock moved, Patterson seconded, to adjourn into executive session in accordance with O.R.C. 121.22 (G)(2) to consider the appointment, employment, dismissal, discipline, promotion, demotion, or compensation of a public employee or official.

Executive session included trustees, fiscal officer, Wilhelm, and Keegan Moss at 7:56.

Moss left executive session at 8:08.

Executive session concluded at 8:15.

* Heacock moved, Patterson seconded, to hire Keegan Moss for a probationary three-month period at a rate of \$17.50/hour. Roll Call: Heacock yes, Patterson yes, ~~Strain~~ Green yes.

Patterson moved, Heacock seconded, to adjourn. Time 8:27 PM.






