Cardington Township held their regular meeting on July 11, 2022 at 7:00 PM in the township garage. The meeting was opened with pledge to flag and prayer by Heacock.

Trustees: Heacock and Green. (Patterson excused)

Fiscal Officer: Hardwick.

Zoning Inspector: Robinson.

Employees: Bouillon, Moss, Wilhelm.

Others: David Smith.

MINUTES:

* Hardwick read the minutes of the special June 20th meeting. Heacock moved, Green seconded, to approve the minutes as read. Roll Call: Heacock yes, Green yes.

FINANCIAL:

* The following bills were presented to the board for examination (listed at end of minutes): 16554-16576 and electronic payments 9 & 10. Heacock moved, Green seconded, to approve said bills. Roll Call: Heacock yes, Green yes.

* Hardwick presented the Township's Cash Summary by Fund report and Fund Status report. The June bank reconciliation was distributed for signing by the board. Heacock moved, Green seconded, to accept them as submitted. Roll Call: Heacock yes, Green yes.

* Heacock moved, Green seconded, to approve the creation of a fund for OPWC grant: Fund 4403 (TR 129 culvert replacement). Roll Call: Heacock yes, Green yes.

* Green moved, Heacock seconded, to approve setting appropriations for Fund 4403 at \$63,569 (state share of OPWC), increasing appropriations for Road Levy Fund (2141) by \$29,387 (local share of OPWC), and to increase appropriations for ARPA Fund (2272) by \$227.91 (extra distribution of federal American Rescue Plan funds). Roll Call: Heacock yes, Green yes.

* Hardwick presented the 2023 tax budget. Heacock moved, Green seconded, to approve the tax budget. Roll Call: Heacock yes, Green yes.

* Heacock stated that he left a message for Greg Gompf at Gompf Funeral Service. The Township has requested Gompf's to obtain a written statement from Daniel Marquardt's ex-wife that he was indigent. The Township would like to submit this letter to the State with application for reimbursement.

ZONING:

* Heacock and Green both received phone calls from Cinnamon Potter with an update on her pursuit to clean up the Maniaci property and remove the people living in the house.

* Robinson reported that the Maniaci property is getting mowed; some junk may have been removed but still many junk mowers at the rear of the property. Lynn Beveridge's property was mowed – as his letter requested. He sent a letter to MK Capital LLC on July 5 asking they mow 4551 TR 66 by July 15 – it has not been mowed as of today. He said it appears a new house is in the works by Ryan Beveridge at 4565 TR 66; Robinson will make contact when a contractor mobilizes. He had an inquiry from Elizabeth Kline regarding Beulah's trailer park near CYT. She requested zoning information and covenant restrictions; he directed her to the Township's website and the County Auditor. He speculates that Beulah is up for sale; they have tax and utility delinquencies.

* Lot split Rodney James 4114 TR 134 1.74 acres fee \$100.

ROADS:

* Moss reported that the road crew crack patched TR128, have been filling potholes with cold patch and mowing. The cannot use hot mix or grader patch without the dump truck.

EQUIPMENT:

* Ronk Towing towed the dump truck to Coughlin in Circleville. Coughlin could not put the truck on a lift and would not do the repair. Today, Ronk towed the dump truck to Aber's Truck Center in Ashland for the repair. Trustees discussed the need for a dump truck. Green said

Anchor Preservations is going out of business and has a dump truck; he asked Wilhelm to see if it would be of use to the Township.

* Trustees discussed tree trimming. Wilhelm will take Moss out to make a list of trees that need trimmed. Always Chipper tree trimming has been busy cleaning up after the June storm.

MISC:

* The Township received thank yous from Tina Radel for flowers from Loren Radel's memorial and from Sherry Casto for clearing her road after the storm.

* Heacock discussed that he is open to paying the road workers twice per month instead of once a month if that would be helpful to them. Green stated that he recently read that elected officials can only be paid once per month.

* Wilhelm submitted a letter of resignation with his last work day of July 31. Heacock moved, Green seconded, to accept Wilhelm's resignation. Roll Call: Heacock yes, Green yes.

* Heacock obtained two quotes for a generator for the Township garage – possibly using federal ARPA money for this project. The estimate from Menard's was \$5,657 for just the generator-no installation. The estimate from K & L Electric was \$7,989.10 for the generator and installation. Heacock will obtain another quote that also includes the generator and installation; this is to ensure compliance with the procurement of federal funds.

Heacock moved, Green seconded, to adjourn. Time 7:50 PM.
