Cardington Township held their year-end meeting on December 29, 2022 at 7:00 PM in the township office. The meeting was opened with pledge to flag and prayer by Heacock. Trustees: Heacock, Patterson, and Green.
Fiscal Officer: Hardwick.

MINUTES:

* Hardwick read the minutes of the December, 12th meeting. Patterson moved, Green seconded, to approve the minutes as read and corrected. Roll Call: Heacock yes, Patterson yes, Green yes.

FINANCIAL:

* The following bills were presented to the board for examination (listed at end of minutes): 16695 - 16713 and electronic payments 26 - 28. Heacock moved, Green seconded, to approve said bills. Roll Call: Heacock yes, Patterson yes, Green yes.

ZONING:

* Heacock moved, Patterson seconded, to reappoint Richard Cook to the Zoning Appeals Board and Pat Drouhard to the Zoning Commission Board for five-year terms that expire December 31, 2027. Roll Call: Heacock yes, Patterson yes, Green yes.

SALARY:

* Heacock moved, Patterson seconded, to pass the following resolution:
"Trustees and fiscal officer of Cardington Township in Morrow County are entitled to the maximum compensation permitted per the Ohio Revised Code" for 2023. This is in response to AG Opinion No. 2000-043 issued late December 2000. Roll call: Heacock yes, Patterson yes, Green yes.

* Heacock moved, Green seconded, to increase zoning inspector, Leonard Robinson's monthly salary 3% (from \$502.55 to \$517.63). Roll Call: Heacock yes, Patterson yes, Green yes.

* Trustees decided to maintain Bouillon and Moss' hourly rates since they were increased August 1. Trustees will survey road worker hourly rates in other townships.

ROADS:

* Trustees discussed summer road work projects.

MISC:

* The Village of Cardington sent the Township a letter about obtaining an annual backflow inspection. Trustees will ask Ohio Township Association for guidance for electric aggregation bids.

* The joint meeting with the Village will be January 3 at 6:30 PM. The Township's organizational meeting will be immediately after the meeting with the Village.
