Cardington Township held their regular meeting on June12, 2023 at 7:00 PM in the township office. The meeting was opened with pledge to flag and prayer by Heacock.

Trustees: Heacock, Patterson, Green.

Fiscal Officer: Hardwick. Employees: Moss and Smith.

Others: Jim Jahn-County Treasurer, Conni McChesney-County Auditor, Jon Mason, County Commissioner, Tom Blankenship, and David Smith.

# MINUTES:

\* Hardwick read the minutes of the May 8th, May 18th, and June 7th meetings. Patterson moved, Green seconded, to approve the minutes as read. Roll Call: Heacock yes, Patterson yes, Green yes.

### DISCUSSION:

\* The newly elected county officials are attending public meetings. McChesney reported that property values are going up an average of 39% county wide. Mason shared that the county is working on a new garage for the County Engineer's office. Jahn is working on reducing the delinquent property taxes in the county. The total of delinquent taxes in Cardington Township is \$86,609 or 2.9% of the county total.

### ZONING:

- \* Patterson received one lot split from Brent Russell. Lot split Todd & Jamie Etgen, CR 136, 1.99 acres fee \$100.
- \* Patterson also related that Dan Wood has resigned from the zoning appeals board.

## ROADS:

\* Moss reported that Crawford Construction Co. completed the culvert replacement on TR 129, and Iberia Earthworm completed summer paving and chip & seal. He has completed one round of mowing. More tires have been dumped; he will dispose of them at Mid Ohio Sanitation. Limestone has been ordered from Mitchell Trucking.

## **EOUIPMENT:**

\* Moss gave an update on equipment. He will service the Ford tomorrow. The fire department is hosting a touch-a-truck event. The Township will take the truck and tractor. Trustees discussed decals for the vehicles. Hartman Printing quoted \$192 for the decals. Moss was instructed to get a quote to fix the dent on the front of the truck. Moss had two prices for drag-a-box: \$12,000 and \$30,000. This could be used instead of the grader. The grader needs a lot of work to get it functional.

- \* Patterson and Moss completed the ODOT sign grant order. Hardwick will input it before the due date on Friday. Newsletter articles were discussed.
- \* Heacock moved, Patterson seconded, to pre-pay the minimum of 300 gallons of propane from Central Ohio Farmers Co-op at \$1.94/gallon. Roll Call: Heacock yes, Patterson yes, Green yes. Heacock will contact Central Ohio Farmers Co-op about the propane order.

## FINANCIAL:

- \* Heacock moved, Patterson seconded, to inspect and sign checks 16808-16830 and electronic payment 16 (check #16824 was voided). Roll Call: Heacock yes, Patterson yes, Green yes.
- \* Hardwick presented the Township's Cash Summary by Fund report and Fund Status report. The May bank reconciliation was distributed for signing by the board. Hardwick
