Held July 10, 2023

Cardington Township held their regular meeting on July 10, 2023 at 7:00 PM in the township office. The meeting was opened with pledge to flag and prayer by Heacock.

Trustees: Heacock and Green. (Patterson excused)

Fiscal Officer: Hardwick.

Zoning Inspector: Toombs.

Employees: Moss and Smith.

Others: Tim Siegfried, County Commissioner.

**DISCUSSION:**

\* Siegfried shared that the county is celebrating 175 years and provided an update of county activities.

**MINUTES:**

\* Hardwick read the minutes of the June 12<sup>th</sup> meeting. Heacock moved, Green seconded, to approve the minutes as read. Roll Call: Heacock yes, Green yes.

**ZONING:**

\* Toombs reported that he is working with Brent Russell on a zoning permit variance at 4432 CR 134 for wind turbine for power generation. They are waiting to receive the zoning permit fee before proceeding any further. Once received, the zoning appeals board will need to convene for this matter.

\* A property on TR 66 asked about solar panel installation on a roof – a zoning permit is not needed for this.

\* The junk vehicles on the Lehner property on TR 138 was discussed. As noted in the June 7 minutes: Darrell, the resident at the property said he needed 30 days to clean up the junk vehicles. 30 days have passed and there are still junk vehicles. Toombs will send Lehner a formal letter.

\* Doubikin on TR 138 still has a block in the road right of way that is a hazard. Heacock will talk to the property owner again. Heacock will also contact Iberia Earthworm for a quote for roadwork at the curve on TR 138 and for work on TR 134.

\* Green shared that 1970 CR 11 has three new sheds on the property. Zoning permits were not issued for these. Toombs will send a letter.

\* Toombs responded to an email from a builder about a lot split/new build on SR 529. He received a complaint about a camper on the Maniaci property. The camper had been in the road right of way; the camper was moved back. This property is now in probate. The Mollett property on US Rt 42 was discussed. Robinson had sent the owner a letter in December when a new trailer showed up on the property. Owner needs to have property surveyed, a lot split, and septic system. There is now a camper in front of the trailer. The Flores property on TR 139 was discussed. A zoning permit had been issued, a structure was built, but the campers never went away. There was a fire on the property this spring.

**ROADS:**

\* Moss reported that the road crew continues with mowing, trimming, and weed control. They will soon be doing repairs to the north end of TR 66. They plan to crack patch four roads and grader patch six roads. The grader is running but leaking.

**EQUIPMENT:**

\* Moss will get prices for a welder. The Ford truck has Cardington Township lettering from Hartman Printing. The tractor lettering has not been completed yet. The touch a truck event at the Village did not happen due to a fire at Hoffman Meats. Moss installed a new windshield for the tractor after a rock broke it. Heacock shared that he called Fyda for a status on the new truck; he left a message.

**MISC:**

\* Heacock called Central Ohio Farmers Co-op. The Township's propane balance from last year was used to cover this year's pre-pay order.

\* Hardwick shared that she submitted the ODOT sign grant application. The Township newsletter was mailed. Check 16820 to Asphalt Materials was a bill for the cemetery, and the cemetery reimbursed the Township on June 22.

\* The Township received a letter from Ford for a recall on the truck. Heacock will call Mathews Ford to schedule an appointment.

\* Trustees discussed possible OPWC projects to apply for in the fall. They decided repaving TR 144 would be a good project with the township providing 26% of the local share. Hardwick will contact the county engineer's office for an estimate.

FINANCIAL:


\* Heacock moved, Green seconded, to inspect and sign checks 16831-16854 and electronic payments 18, 20, 22, 23. Roll Call: Heacock yes, Green yes.

\* Hardwick presented the Township's Cash Summary by Fund report and Fund Status report. The June bank reconciliation was distributed for signing by the board. Hardwick reported that she called the City of Columbus about the refund she had applied for. Columbus confirmed that they received the paper work but it would take time to process. Roll Call: Heacock yes, Green yes.

\* Hardwick presented the 2024 tax budget. Green moved, Heacock seconded, to approve the tax budget. Roll Call: Heacock yes, Green yes.
