Cardington Township held their year-end meeting on December 28, 2023 at 9:35 AM in the township office. The meeting was opened with pledge to flag and prayer by Heacock.

Trustees: Heacock, Patterson, and Green.

Fiscal Officer: Hardwick.

**MINUTES:**

\* Hardwick read the minutes of the December 11<sup>th</sup> meeting. Patterson moved, Heacock seconded, to approve the minutes as read. Roll Call: Heacock yes, Patterson yes, Green yes.

**ZONING:**

\* Permit #2023-11-25CT Robert Diles, 2791 CR 137, pole barn, fee \$30

\* Heacock moved, Green seconded, to reappoint Tom Blankenship to the zoning appeals board and Matt Yake to the zoning commission board for five-year terms that expire December 31, 2028. Roll Call: Heacock yes, Patterson yes, Green yes.

\* Patterson shared that Makenzie Coulter agreed to serve on the zoning commission board. Trustees also noted that the Mollett property on US 42 has many junk vehicles.

**SALARY:**

\* Heacock moved, Patterson seconded, to pass the following resolution:

“Trustees and fiscal officer of Cardington Township in Morrow County are entitled to the maximum compensation permitted per the Ohio Revised Code” for 2024. This is in response to AG Opinion No. 2000-043 issued late December 2000. Roll call: Heacock yes, Patterson yes, Green yes.

\* Trustees discussed Moss’ evaluation. Heacock moved, Green seconded, to increase Keegen Moss’ hourly rate from \$19.00 to \$19.50. Roll Call: Heacock yes, Patterson yes, Green yes.

\* Trustees decided to maintain Harvey Smith’s and Chris Toombs’s rates of pay since they have been employed less than one year.

**ROADS:**

\* Trustees will discuss summer road work projects at the January meeting.

**EQUIPMENT:**

\* Heacock shared that he signed over the title of the 2008 dump truck to Matt Crum and that the next piece of equipment the Township may need in the future would be a tractor and mower.

**MISC:**

\* The Village of Cardington sent the Township a letter about obtaining an annual backflow inspection; Heacock will contact Levering Plumbing.

\* Harbor Freight did not have first aid kits, so Hardwick ordered three from Amazon. Hardwick shared that she is working on insurance renewal paperwork for Rinehart Insurance. Heacock reported that Soil & Water Conservation will have their annual meeting on January 24, but he is not able to attend.

\* The joint meeting with the Village will be January 3 at 6:30 PM. The Township’s organizational meeting will be immediately after the meeting with the Village.
