* Hardwick read the minutes of the December 11th meeting. Patterson moved, Heacock seconded, to approve the minutes as read. Roll Call: Heacock yes, Patterson yes, Green

ZONING:

- * Permit #2023-11-25CT Robert Diles, 2791 CR 137, pole barn, fee \$30
- * Heacock moved, Green seconded, to reappoint Tom Blankenship to the zoning appeals board and Matt Yake to the zoning commission board for five-year terms that expire December 31, 2028. Roll Call: Heacock yes, Patterson yes, Green yes.
- * Patterson shared that Makenzie Coulter agreed to serve on the zoning commission board. Trustees also noted that the Mollett property on US 42 has many junk vehicles.

SALARY:

EQUIPMENT:
