Cardington Township held a regular meeting on June 10, 2024 at 7:00 PM in the township office. The meeting was opened with pledge to flag and prayer by Heacock.

MINUTES:

* Hardwick read the minutes of the May 13th meeting. Patterson moved, Heacock seconded, to approve the minutes as read and corrected. Roll Call: Heacock yes, Patterson yes, Green yes.

ZONING:

* Toombs reported that the Wuertz trust is working on lot splits. Toombs spoke with property owner on TR66; owner needs to contact Health Dept for septic approval - then obtain zoning permit. Davis (TR141) made a little progress cleaning up junk vehicles, the Maniaci neighbors (CR149) made a complaint – told to contact Health Dept. Landis (TR66) spoke to Toombs about downsizing his property.

* The Zoning Board of Commission met on Monday, June 3 with Plan4Land; the minutes of the meeting were distributed. The Board will meet again on Monday, June 17 at 6:30 PM.

* Trustees discussed that when a vacancy opens on the Zoning Board of Commission or Appeals Board, they could interview candidates who are interested in serving.

ROADS:

* Moss reported he started a second round of mowing, crack patched seven roads before he had problems with the machine. Company will let him use the machine for another week in August. The posts of the guardrail on TR144 (near US Rt 42) are starting to rot; he will inquire with County Engineer about replacement. He discussed advertising signs that are placed at intersections that are a nuisance.

* Patterson shared that he discussed with the County Prosecutor the problem when cars parked on TR138 and blocked neighbors' driveways. Smith shared two Ohio Revised Code sections: 5571.14 (permits township to remove obstructions) and 4511.68 (parking prohibited in front of private driveway). The Township has the authority to remove vehicles if this occurs again.

EQUIPMENT:

* Moss shared that the mower was serviced, Wilson Tire fixed a tractor tire, and Moss fixed a squeal on the backhoe. He has been looking at used tractors; a used tractor is around \$80,000.

* Moss would like to add a sprayer to the truck for weed control. He found one on Facebook for \$500 – 50 gallon, pump, 150' hose. Heacock moved, Green seconded, to authorize Moss to barter for a sprayer, up to \$500, Moss will pay and Township will reimburse him. Roll Call: Heacock yes, Patterson yes, Green yes.

MISC:

* The Township was notified that they will receive OPWC funding to repave TR144. Township can bid now but cannot award bid until the OPWC agreement is signed. OPWC should email this agreement to Heacock around July 1. Trustees decided to advertise to open bids at July 8 meeting.

* Trustees decided to pre-pay for 700 gallons of propane from Central Ohio Farmers Co-op at \$1.89/gallon. Hardwick will prepare the check for this at the July meeting.

* Hardwick read a letter from Jim Jahn, County Treasurer. He is working with the Morrow County Land Bank. They would like to inform trustees to inform them of any blight properties in the township.

FINANCIAL:

* Patterson moved, Heacock seconded, to inspect and sign checks 17050-17072 & electronic payment 16. Roll Call: Heacock yes, Patterson yes, Green yes.



* Green moved, Heacock seconded, to approve setting appropriations for Fund 4404 at \$121,669 (state share of OPWC) and increasing appropriations for Road Levy Fund (2141) by \$52,144 (local share of OPWC). Roll Call: Heacock yes, Patterson, Green yes.


Patterson moved, Green seconded, to adjourn. Time 8:10 PM.
