Cardington Township held a regular meeting on July 8, 2024 at 7:00 PM in the township office. The meeting was opened with pledge to flag and prayer by Heacock.

Trustees: Heacock, Patterson, Green Fiscal Officer: Hardwick
 Employees: Moss & Smith
 Others: Tim Abraham, David Smith, and a representative of Small's Asphalt Paving

OPWC BIDS:

* Trustees opened and read four bids for TR144 improvements:

Small's Asphalt Paving, Inc.	\$175,332.90
Mid Ohio Paving, Inc.	\$153,223.40
Kokosing Construction Company, Inc.	\$168,500.00
Shelly & Sands, Inc.	\$184,309.20

* Green moved, Patterson seconded to award the OPWC TR 144 improvements contract to Mid Ohio Paving in the amount of \$153,223.40 as the lowest and best bid. Roll Call: Heacock yes, Patterson yes, Green yes.

DISCUSSION:

* Abraham, County Commissioner, provided an update of county activities.

MINUTES:

* Hardwick read the minutes of the June 10th meeting. Patterson moved, Green seconded, to approve the minutes as read. Roll Call: Heacock yes, Patterson yes, Green yes.

ZONING:

* Hardwick read Toombs's zoning report. Toombs sent another letter to Mollett (US Rt 42). He spoke to Lori McGee about the vehicles on the Davis property (TR 141); she is continuing to work on the situation. Toombs is still waiting to hear back from the Health Dept. about the Maniaci property (CR 149).

* Lot split Wuertz trust, CR 137 and TR 130, 15.5 acres fee \$100.

* The Zoning Board of Commission met on Monday, June 17 and discussed the strengths and weaknesses of the current zoning regulations; the minutes of the meeting were distributed. The Zoning Board of Commission will meet again on July 30 at 6:30 PM.

* Trustees discussed Maniaci property (CR 149). They have spoken to the people living on this property many times over the last two years without cooperation. Trustees feel it is time to declare the property a nuisance and would like to invite Tom Smith, County Prosecutor, to the next township meeting.

ROADS:

* Moss reported he started a third round of mowing and is preparing roads for summer paving and chip and seal. Small's Asphalt Paving plans to start summer paving in July. Moss has sprayed weeds and trimmed trees. He has contacted Always Chipper about removing some trees. He has obtained a mini excavator from Holmes Rental for one month to work on culverts.

* The Township is responsible for the guardrail on TR 144. Moss will call Mid Ohio Paving to see if they would provide a quote to replace it.

* Heacock reported that he spoke with the County Prosecutor about advertising signs that are placed in the ground that are a nuisance. Smith advised that they can be removed as they are a hazard in the road right of ways and in the way of mowing. If they are campaign signs: either remove to mow and replace them in the ground or call the candidate and ask them to relocate their signs.

EQUIPMENT:

* Moss shared that the sprayer he saw on Facebook sold before could make an offer. Hartman Printing put lettering on the new truck. The mower deck is worn out; Moss will get a quote from Dexter - he estimates that it will cost around \$19,000.

MISC:

* Rinehart Insurance sent an email that to increase employee dishonesty insurance to \$160,000 with a \$2,500 deductible would increase the annual premium by \$322. Hardwick reported that her bond is for \$135,000 for four years at a cost of \$656 and trustees' bonds are \$5,000 each with no cost. Trustees would like more information from Rinehart Insurance.

* Hardwick shared an Auditor of State bulletin that requires all employees to complete fraud prevention training. She will complete the training, then send the link to trustees and employees to complete.

* Trustees discussed possible OPWC projects to apply for in the fall. Moss recommended repaving TR 132 (between CR 137 and CR 27). Hardwick will contact the county engineer's office for an estimate.


FINANCIAL:




* Hardwick presented the 2025 tax budget. Green moved, Heacock seconded, to approve the tax budget. Roll Call: Heacock yes, Green yes.
